I would like to thank all my brother knights for your prayers, thoughts, and well wishes as I continue to recover from my recent hip replacement surgery. I continue to do in-home therapy, which has really helped me to a speedy recovery. I graduated from using a walker to on-

ly requiring a cane to assist me in moving about from room to room. I hope to be able to function without the assistance of a cane by next week and to be able to drive short distances. I truly believe in the power of prayer and that all of your prayers have helped to make my surgery and recovery a huge success.

Growth in the state of Ohio has been phenomenal the past three months! We started the second half of this fraternal year by bringing in 172 new members in the month of January, which was our best recruiting month this fraternal year. We topped that a by bringing in 178 new members in the month of February, even though it was the shortest month of the year. The month of March was even better with over 220 new members and counting. We still have two more days to go in this month, which should give us more than 1360 new members so far, this fraternal year. This means that we will need somewhere around 500 new members, maybe even less, to reach our goal of 1,860 new members for the fraternal year. But we can't ease up

on our recruiting efforts; we must carry this momentum from our third quarter into the last three months of this fraternal year and place this great state of Ohio in the Circle of Honor once again. I am counting on all our councils to continue asking and giving Catholic men the opportunity to become a Knight of Columbus.

The Star Council Award is still our No. 1 Goal! Our Star Council Award deadline is now three months away. Each month, PSD And Special Reports Chairman, Ken Girt issues a Star Council Status report that is sent to all Grand Knights. I ask you to review the status of your council, especially those councils that will be close to achieving the six requirements for Star Council. I have set a goal for each of our District Deputies to have at least one of his coun-

cils achieve the Star Council Award. Our Supreme Council quota for Star Councils in Ohio is 59. I think we can achieve that quota and exceed it! As State Deputy, I have set the Star Council Award as the Number One goal for all councils in Ohio. State General Program Director Mike Jordon and I have structured our state program contest after the Star Council Award criteria. And why is it important for every council to set their sights on the Star Council Award? This award is the one Supreme Council award that recognizes all the main efforts of an active council of our Order. Achieving membership growth, protecting our youth, providing insurance for our members, demonstrating our acts of charity (which is the first principle of our Order), to report on those acts of charity and volunteer hours on our fraternal

survey, and to report to Supreme that each council has a dedicated Grand Knight, council officers and service program directors. Our Ohio councils have until June 30 to complete the six Star Council Requirements.

The 125th annual State Convention is just a little more than a month away, and, all Grand Knights should have received at least their First Call packet from State Secretary Mike Felerski for this historic event. As State Deputy, it's important for me to stress that this information remains important in the operation of the Ohio State Council. I urge Grand Knights to carefully review the mailing's contents and act promptly in responding to the deadlines listed. Delegates should be selected following the rules outlined in the convention mailing. Delegate and guest registrations are due no later than April 26, 2024. There will be no on-site registration at the convention (pre-registration only!). I also would like to bring to your attention, the hotel reservation deadline. The reservation deadline for the discounted room rate and complementary services for the hotel is also April 26, 2024, no exceptions. Hotel reservations need to be made as soon as possible, so please do so immediately.







#### It's Now Crunch Time!

Worthy Brothers,

When you get this today, April 1<sup>st</sup>, you will have until midnight to get those <u>of the year</u> award winners' names and information into the directors.

The next important deadline is April 15<sup>th</sup>. Yes, this is Tax Day, but it is also the last day of reporting. At midnight, our Worthy Webmaster will be turning off the website reporting op-

tion. Before the deadline, make sure all your programs are reported. This means, if you are doing programs in May or June, you must report them before April 15<sup>th</sup>.

Lastly these two very important programs must be completed for your council to be star council and to max out the State Program. First, you must have completed two Fraternal Benefit nights with councils under 100 members having 10 eligible members in attendance. (This is total for both Fraternal Benefits Nights - example 5 one night and 5 the second night) and council with over 100 members having at least 14 eligible members attend. (example 7 first night and 7 the second night).

The final program that councils need to do is to make sure that they are Youth Compliant. You can see this on PSD Brother Ken Girt's Star Council Report. This report is sent out no later that the 5<sup>th</sup> of the month. Brothers, being youth compliant is very important, since we stress doing Family activities. Councils might do the soccer challenge, basketball free throw, and many other activities that involve the youth.

I'm asking all councils between now and April 13 to check to make sure that your point total is correct, and if not, contact the director(s) of the area(s) in question.

I pray that you all had a very Blessed Easter. He is truly Risen and is working in our lives daily!

Remember, you must have a least 2 Faith in Action Family Programs and up to 3 council choice activities to do it, along with Family of the Year and your family director being youth compliant. So, if you still need to report some family activities, make sure you have already reported your 2 Faith in Action Family Programs. If not, Family of the Month, Keep Christ in Christmas, Family Prayer Night, and Food for Families are popular programs to report, if you have not yet done so already. The rest can be council choice. Maxing out your family service programs can easily be done! Again, feel free to reach out to me if you need assistance in doing so. I will be glad to help!

#### Silver Rose Returns in June


Brother Knights of the Great State of Ohio,

However, since the criteria has changed, and I had limited space on the Star Council Report, I initiated a change in listing the status of the criteria.

Star Council Report "Founders Award" column will now designate the council's status as either "YES" for those who met the crite-

ria and will receive the Founders Award or blank as not yet achieving the criteria.

Here is an example from the March 1, 2024 Fraternal Benefit Event Report:




